The reservation policy is being implemented in respect of all posts which were filled through promotion and recruitment thereafter. The Seniority list capturing the category (SC/ST/OBC status) of employees was prepared as on April 1, 2014.

Hence, the roster prepared by IFCI contains reservation policy applied to all posts filled through recruitment and promotions only after April 1, 2014. In the Roster Summary Sheet "The existing staff position" has been mentioned considering only the manpower recruited /promoted after April 1, 2014 and the same

has been forwarded to the subsequent year.
