On perusal of Transparency report, it is seen that the Organization has displayed large number of information on the web site but it has still not complied some main provisions of the RTI Act. The information in r/o of the following points have either not been uploaded or partially uploaded resulting into inviting RTI application for seeking information on these issues:-

1. It is seen from the audit report that information in respect of programmes to advance understanding of RTIs is not available and also efforts made to encourage public authority to participate in these programmes etc not displayed on the given site.
2. It is also seen from the report that information in r/o training of cpios/APIOs also not available on the site and needs to be looked into.
3. It is observed from report that information in respect of transfer policy and transfer orders is not displayed on the site and needs to be looked into .
4. It is seen that on the given site contract details is not found although email ID is available. This aspect needs to be looked into.
5. It is seen that information in respect of publishing all relevant facts while formulating important policies or announcing decisions which affect public to make the process more interactive- Outline the arrangement for consultation before formulation of policy . This may please be looked into.
6. It is found that information in r/o Grievance redressal mechanism was not available on the given site. This may please be looked into.

In addition to above, the points pointed out by auditor should also be looked into.

It is also proposed that periodic training programmes/seminars on RTI matters be organised so as to update the knowledge of the concerned officers.
