I had sought information on - Effective date from which Management Development Institute Society, has become or would become an autonomous society under the Ministry of Finance, Government of India to which the CPIO has replied that - Since the query does not pertain to IFCI Ltd., you may approach the concerned Ministry directly. There are two problems with this reply - first, so long as Management Development Institute is an Associate of IFCI Limited, any change in its control pertains to IFCI Ltd. Secondly, as per Section 6(3) of the RTI Act, where an application is made to a public authority but the subject matter of the RTI application pertains to another public authority, the CPIO of the public authority receiving the RTI application has to transfer the same to the public authority concerned. The CPIO ought to have transferred the application or such part of it as may be appropriate to that other public authority and informed me (the applicant) immediately about such transfer, which the CPIO has failed to do.

I request redressal of my grievances as have been enumerated above.
