ORDER

This is an order on your RTI Appeal dated 08/10/2020 received on 09/10/2020, preferred against the response to your RTI Application dated 11/08/2020 which was disposed of by the CPIO vide reply no. IFCI/RTI/844/2020 dated 23/09/2020.

2. The undersigned as FAA has considered the grounds raised in the present appeal and point wise disposal of the appeal is as under:-

Para 2 of your RTI Appeal is a mere summarization of the various judgments which the CPIO and FAA as statutory authorities are aware of. Hence the same needs no response.

3. Para 3 of the RTI Appeal are a mere summation of your understanding of the payment of pension and deserve no response. It may also be added here that the CPIO has clearly mentioned that LIC is the organization handling all Annuities that are being paid to the pensioners directly and there is no role that IFCI plays in the disbursement of the same.

In response to para 3(v) you have alleged that the CPIO has carelessly and casually responded. However as FAA, it seems that the CPIO has sought the desired information from the concerned department and then responded to the queries. It does not tantamount to acting in a casual manner. Also it is a fact that IFCI is working with limited manpower owing to the ongoing COVID-19 pandemic and seeing the severity of the situation, it is highly inhumane to comment on the working of IFCI or any public authority for people sitting in the comfort of their homes.

As FAA, it is felt that the CPIO has with proper application of mind and seeking data from the concerned departments answered the queries raised in the RTI Application.

No further intervention is required from the First Appellate Authority. The appeal is disposed of accordingly.

In case the Appellant is not satisfied with this Order, he may, if so desired, prefer a second appeal within 90 days from this order with the following:
