Because the CPIO is collecting the information from the concerned department. CPIO was casual in his replies that he is not supposed to do the research work and ha has grossly failed

	 in his duties to provide the relevant information with respect to concerned flat. 3. Because even in case of collective repairs estimate for each flat is made separately and even due payment is arrived at by aggregating the actual cost of repairs to the different flats. 4. Because the query was with respect specific flat no. 304 Blue Diamond , Juhu Road, Mumbai and not with respect to other flats. The reply of the CPIO is misleading by providing incomplete information. 5. Because the information sought was for a period starting from May 2013 (after vacation of the flat). CPIO is vague in his reply. Neither he has mentioned the period for which the repairs have been carried out, nor the flat numbers of the repaired flat and their location. 6. Because no repairs have been carried to flat no, 304 Blue Diamond , Juhu Road, Mumbai. 7. Because no question of repairs arises since the flat was sold out after its vacation and the reply of CPIO, in this regard, is ambiguous. 8. Because the CPIO has not provided a documentary evidence to support the payment and thus grossly failed in his duties. It is therefore, requested that the required details be furnished at the earliest.
